By Resolution approved on October 25, 2012 your Honorable Board awarded Contract No. 12-534 for Roofing Replacement, 25 Moore Avenue, Mount Kisco, New York to Sony NY Management & Construction Corp. (MBE) in the amount of \$249,000.00, for the period November 8, 2012 through June 7, 2014. The Contract was subsequently executed.

Contract completion is delayed due to construction issues, specifically issues between the contractor and the roofing manufacturer regarding the issuance of the specified warrantee. Therefore, the County now seeks authority from your Honorable Board to amend the October 25, 2012 Resolution budget box end date from June 7, 2014 to December 31, 2015.

All other terms and conditions of the October 25, 2012 Resolution and the Contract shall remain in full force and effect and unchanged.
