**RE:** Request for authority to enter into an agreement with the State of New York, acting by and through the New York State Office for the Aging ("NYSOFA") to accept a grant in the amount of \$1,286,813 in State funds to provide services under the Community Services for the Elderly Act Program for the program period April 1, 2015 through March 31, 2016

---

The County of Westchester (the "County"), acting by and through the Department of Senior Programs and Services (the "Department"), seeks authority from your Honorable Board to enter into an agreement (the "Agreement") with the New York State Office for the Aging ("NYSOFA") to accept a grant in the sum of \$1,286,813 in State funds to provide funding for the Community Services for the Elderly Act Program ("CSE") for the Program period April 1, 2015 through March 31, 2016.

Of the \$1,286,813 in CSE State funds, \$871,833 will be used to provide various services for the elderly for the Program period April 1, 2015 through March 31, 2016. The remaining balance of \$414,980 in funds will be used directly by the Department in accordance with the Program to provide direct services and area agency administration.

The Agreement will serve a public purpose by providing funds needed to provide information and supportive services to help needy seniors remain in their homes and communities thus delaying institutionalization and thereby saving on Medicaid costs to the County, State and federal governments.

The goals and objectives of the Agreement are to provide families and seniors throughout Westchester County with information and assistance services and classes and elderly care-management services.

The goals and objectives of the Agreement are in the County's best interests in terms of fiscal responsibility and public health and safety, as these services promote enabling seniors to remain safely in their homes and communities and to maintain a cost-effective lifestyle. The CSE programs aim to reduce or delay nursing home institutionalization, thereby reducing Medicaid costs for the County, State and Federal governments and improving the general well-being of the County's elderly.

The goals and objectives of the Agreement will be tracked, monitored and evaluated through monthly reporting activities and annual on-site reviews to determine if the contract performance goals and objectives are being met in a fiscally responsible and appropriately safe fashion. The New York State Office for the Aging shall annually monitor and evaluate if the Department is

meeting its requirements to conduct proper oversight. Additionally, client satisfaction is monitored through the use of surveys and bimonthly case management follow-up calls.

The provisions of the Westchester County Procurement Policy are not applicable as the proposed Agreement to accept grant funds does not constitute a procurement.

I certify that my department, a) has copies of, or access to, all applicable laws, rules, regulations, grant applications, and grant agreements (including any master grant agreement), as well as any guidance or instructions received from the agency making the grant (the "Grant Terms"), b) has reviewed the Grant Terms, c) is aware of and understands all of the Grant Terms, and d) can and will comply with all of the Grant Terms.

Accordingly, I recommend adoption of the proposed resolution.
