On February 4, 2015, eight (8) bids were received and opened for Contract No. 14-515 for Mamaroneck River Buffer Restoration – Phase II, Saxon Woods Park, Towns of Mamaroneck and Harrison, New York.

The bids were reviewed by the Department and it was determined that Turco Golf, Inc. submitted the low bid in the amount of \$419,309.13.

The low bidder has been investigated and it has been found that Turco Golf, Inc.:

- Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

The objective of this contract is to stabilize the streambank on the Mamaroneck River using bioengineering techniques along with restoration of the existing freshwater wetland.

This contract is in the public's best interest because it will provide the environmental benefits of reducing flooding and erosion along with creating an improved habitat for wildlife in Saxon Woods Park, thus addressing the County Executive's priority area: Health and the Environment (HE).

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 14-515 be awarded to Turco Golf, Inc. in the amount of \$419,309.13.
