The work required under Contract No. 13-506 between the County of Westchester and Morano Brothers Corp., 2045 Albany Post Road, Croton-on-Hudson, New York 10520 has been completed.

The department tracked scheduling and accomplishments by the contractor and performed on-site inspections to ensure the successful completion of this project.

A final inspection has been made which indicates that the work meets the terms and requirements of the contract.

It is recommended that your Honorable Board take appropriate action to accept the completed work and approve the Final Contract Amount of \$4,877,129.00. The work required under Contract No. 13-506 consists of all necessary labor, materials and equipment for Rehabilitation of Taxiway A, Westchester County Airport, Towns of Harrison and North Castle and Village of Rye Brook, New York.

Payment for this contract will be made from FAA Funds and the Airport Special Revenue Fund, not the County General Fund and will not impact the County tax levy.

Payment shall be made in accordance with all applicable laws, including, without limitation, the New York State Lien Law.
