On March 11, 2015, eight (8) bids were received and opened for Contract No. 14-508 for Roadway Resurfacing and Fencing Improvements, Lenoir Park, Yonkers, New York.

The bids were reviewed by the Department and it was determined that MVM Construction LLC submitted the low bid in the amount of \$390,000.00.

The low bidder has been investigated and it has been found that MVM Construction LLC:

- Performed satisfactory work in the past for the County.  
 Past experience has been investigated and found satisfactory.

The objective of this contract is to replace substandard areas of asphalt paving, thus addressing the County Executive's priority area: Safety and Security (SS).

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that all asphalt pathways, driveways and parking lots at Lenoir Park meet current codes and standards as well as reducing the County's annual maintenance costs.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 14-508 be awarded to MVM Construction LLC in the amount of \$390,000.00.
