Resolution to Extend the Tolontract No. 10-50-7

By Resolution approved on October 27, 2011 your Honorable Board awarded Contract No. 10-509-Rev. for HVAC Equipment Upgrades and Odor Control Improvements, Yonkers Joint Wastewater Treatment Plant, Yonkers, New York to Arben Group LLC in the amount of \$5,979,000.00, for the period from November 10, 2011 through January 3, 2014. The Contract was subsequently executed.

On February 6, 2014, your Honorable Board approved a Resolution to amend the October 27, 2011 Resolution budget box end date from January 3, 2014 to December 31, 2014 due to construction issues and damaged equipment as a result of Hurricane Sandy that delayed construction completion.

Contract completion has been further delayed due to construction issues, specifically the contractor had an issue procuring the CEMS gas monitoring equipment. Therefore, the County now seeks authority from your Honorable Board to amend the October 27, 2011 Resolution budget box end date from December 31, 2014 to December 31, 2015.

All other terms and conditions of the October 27, 2011 Resolution and the Contract shall remain in full force and effect and unchanged.

Resolution to accomplish the foregoing is attached.
