The work required under Contract No. 10-208 between the County of Westchester and Safety Marking, Inc., 460 Bostwick Avenue, Bridgeport, Connecticut 06605 has been completed.

The department tracked scheduling and accomplishments by the contractor and performed on-site inspections to ensure the successful completion of this project.

A final inspection has been made which indicates that the work meets the terms and requirements of the contract.

Payment shall be made from the Airport Special Revenue Fund, not the County General Fund and will not impact the County tax levy.
