RE: Authority to determine that a proposed “short form” agreement with Callyo 2009 Corporation for the provision of wireless services for undercover police investigations qualifies as a “Sole Source” procurement pursuant to Section 9 of the Westchester County Procurement Policy.

---

The County of Westchester, acting by and through the Department of Public Safety (the “Department”), seeks to enter into a “short form” agreement with Callyo 2009 Corporation (“Callyo”), pursuant to which Callyo will provide a wireless service that would enable undercover police officers to utilize their existing cellular phones as wireless bugs to record phone conversations for investigative purposes. The term of the proposed agreement would commence April 1, 2015 and continue through March 31, 2016. In consideration for services rendered, the County will pay Callyo an amount not-to-exceed \$5,000.00.

Ordinarily, under Section 5(a) of the Procurement Policy, the County is required to solicit written or oral quotations from no fewer than three persons customarily providing said goods or services. However, after reasonable investigation, the Department has determined that Callyo is the only practicable source to provide these services, and, accordingly, recommends to your Honorable Board that the proposed contract with Callyo qualify as a “Sole Source” procurement pursuant to Section 9 of the County Procurement Policy.

An appropriate resolution is herewith attached for your Honorable Board’s consideration.
