SUBJECT: Authority to enter into:

- 1) a grant agreement with the United States Department of Housing and Urban Development to accept a grant in the amount of \$168,119.00 for services regarding the County's Continuum of Care, for a term from June 1, 2015 through May 31, 2016; and
- 2) an agreement with Program Design and Development, LLC, pursuant to which it will provide various services regarding the County's Continuum of Care, for an amount not-to-exceed \$168,119.00, for a term from June 1, 2015 through May 31, 2016.

Authority is respectfully requested from your Honorable Board for the County of Westchester (the "County") to enter into a grant agreement with the United States Department of Housing and Urban Development ("HUD"), pursuant to which the County will accept from HUD a grant (the "Grant") in the amount of \$168,119.00 for services regarding the County's Continuum of Care (the "Services"), for a term from June 1, 2015 through May 31, 2016 (the "Grant Agreement").

I certify that my department, a) has copies of, or access to, all applicable laws, rules, regulations, grant applications, and grant agreements (including any master grant agreement), as well as any guidance or instructions received from the agency making the grant (the "Grant Terms"), b) has reviewed the Grant Terms, c) is aware of and understands all of the Grant Terms, and d) can and will comply with all of the Grant Terms.

Authority is also respectfully requested from your Honorable Board for the County to enter into an agreement with Program Design and Development, LLC ("PD&D"), pursuant to which PD&D will provide the Services, for an amount not-to-exceed \$168,119.00, pursuant to an approved budget, for a term from June 1, 2015 through May 31, 2016 (the "PD&D Agreement"). The PD&D Agreement will be funded by the funds to be received by the County under the Grant Agreement.

The Services shall include various coordination activities, project evaluation services, project monitoring services, and services to assist the County in complying with HUD requirements, as well as development of a system to increase participation from currently low-participating stakeholders.

The PD&D Agreement will authorize PD&D to subcontract with Social Policy Innovations, Inc. for the project evaluation portion of the Services.

The proposed Grant Agreement will serve a public purpose by providing the County with Federal funds for the Services. The proposed PD&D Agreement will serve a public purpose by providing the Services funded by the Grant.

The goal and objective of the proposed Grant Agreement is to provide the County with Federal funds for the Services. The goal and objective of the proposed PD&D Agreement is to provide the County with the Services funded by the Grant.

The goal and objective of the proposed Grant Agreement is in the best interests of the County in terms of fiscal responsibility, as it will make available to the County federal funds for the aforementioned Services. The goal and objective of the proposed PD&D Agreement is in the best interests of the County in terms of health, as it will provide the aforementioned Grant-funded Services that will improve the County's Continuum of Care.

The goals and objectives of the proposed agreements will be tracked and monitored by the Department of Community Mental Health.

The procurement of the proposed PD&D Agreement is exempt from the requirements of the County's Procurement Policy pursuant to Section 3(a)(xi) thereof, which exempts "any procurement made pursuant to procurement procedures provided for under any other federal or state law applicable to such procurement," as the County complied with the procedures specified by HUD for the grant.

I respectfully recommend the adoption of the attached Resolution.
