SUBJECT: Authority to enter into an agreement with the United States Department of Housing and Urban Development (“HUD”) in order to accept a grant in the amount of \$345,652.00 to be used to pay for work and services related to the County’s Homeless Management Information System, under HUD’s Continuum of Care Program, for a term commencing August 1, 2015 and continuing through July 31, 2016.

Authority is respectfully requested from your Honorable Board for the County of Westchester, acting by and through its Department of Social Services (the “Department”), (the “County”) to enter into an agreement with the United States Department of Housing and Urban Development (“HUD”) in order to accept a grant in the amount of \$345,652.00 under HUD’s Continuum of Care Program, to pay for work and services related to the County’s Homeless Management Information System (“HMIS”), for a term commencing August 1, 2015 and continuing through July 31, 2016.

I certify that my department, a) has copies of, or access to, all applicable laws, rules, regulations, grant applications, and grant agreements (including any master grant agreement), as well as any guidance or instructions received from the agency making the grant (the “Grant Terms”), b) has reviewed the Grant Terms, c) is aware of and understands all of the Grant Terms, and d) can and will comply with all of the Grant Terms.

The proposed agreement will serve a public purpose by providing the funds necessary for the County to pay for work and services related to the County’s HMIS, which is designed to

track and monitor the placement and status of the homeless clients of the Department and thereby better serve them.

The goal and objective of the proposed agreement is to provide the funds necessary for the County to pay for work and services related to the County's HMIS.

The goal and objective of the proposed agreement is in the best interests of the County in terms of fiscal responsibility, as the proposed agreement will make available to the County the funds necessary for the County to pay for work and services related to the County's HMIS. The goal and objective of the proposed agreement is also in the best interests of the County in terms of public health and safety, as the County's HMIS, which will be funded by the proposed agreement, is designed to track and monitor the placement and status of the homeless clients of the Department and thereby better serve them.

The goal and objective of the proposed agreement will be tracked and monitored by the Department, in accordance with the requirements of HUD. The Department will be required to prepare and submit an Annual Performance Report to HUD as a requirement of receiving the funding to be provided under the proposed agreement.

The proposed agreement does not constitute procurement. Accordingly, the provisions of the Westchester County Procurement Policy do not apply.

I respectfully recommend your Honorable Board's approval of the attached Resolution.
