The County of Westchester (the "County") operates a UHF trunked analog two-way radio system for use by the Department of Emergency Services, the Department of Public Works and Transportation, local fire departments and local emergency medical services. As part of this system, the County installed a radio antenna and related equipment on property owned by the City of Peekskill (the "City") and located at 181 Benefield Blvd., Peekskill, New York. By Resolution approved on June 16, 2005 the County was authorized to enter into an agreement for these purposes with the City for a term of five (5) years, with a mutual option to extend the agreement for an additional five (5) years. By Resolution dated November 18, 2010, the County was authorized to enter into an amendment to extend the The agreement, as amended, expires on August 9, 2015.

Both parties are desirous of extending the agreement for an additional five (5) year term and also to amend the agreement in order to modify and install additional antennas and radio equipment. Accordingly, authority is requested from your Honorable Board to extend the agreement for an additional five (5) year term, commencing August 10, 2015. The County will pay an annual license fee of \$1.00 and the parties will indemnify and hold harmless the other from and against any and all liability, damage, claims, demands, costs, judgments, fees, attorneys' fees or loss arising directly or indirectly out of the performance or failure to perform and defend and provide defense for any and all claims, demands or cause of action directly or indirectly arising out of the agreement.

The public purpose of this agreement is the continued operation of the emergency radio system. County staff members monitor the operation of the equipment on a regular basis.

All other terms and conditions of the agreement shall remain in full force and effect.
