On August 5, 2015, four (4) bids were received and opened for Contract No. 15-513 for Resurfacing and Related Improvements, Tuckahoe Road (C.R. No. 36), from Winnebago Road to Bronx River Parkway, a Distance of 0.17 Miles, City of Yonkers, New York

The bids were reviewed by the Department and it was determined that Montesano Brothers, Inc. submitted the low bid in the amount of \$314,548.00.

The low bidder has been investigated and it has been found that Montesano Brothers, Inc.:

- Performed satisfactory work in the past for the County.  
 Past experience has been investigated and found satisfactory.

The objective of this contract is to replace substandard areas of asphalt paving, thus addressing the County Executive's priority area: Safety and Security (SS).

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.
