Re: Authority for the County of Westchester to enter into an intermunicipal agreement with the Village of Scarsdale to license approximately 3.7 acres of parkland to the Village for municipal recreational purposes.

Authority is requested to enter into an intermunicipal agreement (“IMA”) with the Village of Scarsdale (the “Village”) to license for a five-year term the use of approximately 3.7 acres of parkland on the Bronx River Reservation located near the Scarsdale train station (the “Licensed Premises”). This property is described as a portion of Parcel 1, Sheet 17, a portion of Parcel 2, and Parcel 3, Sheet 18, on the Maps of the Land of the Bronx River Reservation. Since 1985, the Village has used the property pursuant to license agreements solely for municipal recreation purposes and has kept the property open to all County residents.

It is now proposed that a new five-year IMA be entered into with the Village in order to continue its use of the Licensed Premises. The Village will continue to utilize the Licensed Premises as a municipal recreation facility for the benefit of all County residents. The Village will provide for its maintenance and supervision at its sole cost and expense, with the exception of the maintenance of the Bronx River water areas, including clearing the river, maintaining the banks and caring for the trees in the Licensed Premises, including removal if necessary, which will be provided by the County. The term will be from May 1, 2015 through April 30, 2020. The annual license fee will be \$1.00.

The ultimate goal of the agreement will be for the public good by providing for a location for recreational activities. This agreement promotes fiscal responsibility as the County will benefit from the Village maintaining the area. The objective of this agreement is to allow the Village to maintain the area with the exception of maintaining the banks and caring for the trees and it will be tracked and monitored by site visits by Department of Parks, Recreation and Conservation staff.

The Board of Legislators authorized this IMA pursuant to Act No. 116-2015 on July 13, 2015 and it was approved by the County Executive on July 16, 2015.

This IMA is exempt from the operation of the Westchester County Procurement Policy pursuant to Section 3 (a)(iii) thereof.

I recommend the adoption of the annexed Resolution.

RESOLUTION

Upon a communication from the Commissioner of Parks, Recreation and Conservation,
be it

RESOLVED, that the County of Westchester (the "County") is hereby authorized to enter into an intermunicipal agreement ("IMA") with the Village of Scarsdale (the "Village") to license a portion of parkland on the Bronx River Reservation located near the Scarsdale train station, consisting of approximately 3.7 acres located in the Village of Scarsdale, New York for a term of five (5) years from May 1, 2015 through April 30, 2020, to be used solely for municipal recreational purposes. The property is described as a portion of Parcel 1, Sheet 17, a portion of Parcel 2, and Parcel 3, Sheet 18; on the Maps of the Land of the Bronx River Reservation; and be it further

RESOLVED, that the Village shall pay to the County an annual license fee of \$1.00 and shall be responsible for all costs and expenses related to the maintenance and supervision of the property, with the exception of the maintenance of the Bronx River water areas, including clearing the river, maintaining the banks and caring for the trees in the Licensed Premises, including removal if necessary, which shall be provided by the County; and be it further

RESOLVED, that the IMA shall contain provisions requiring that the licensed premises shall be open to and benefit all County residents; and be it further

RESOLVED, that the County Executive or his authorized designee is hereby authorized to execute all instruments and take all actions reasonably necessary to implement this Resolution.
