changes necessitated by the modification to the scope of work.

By a resolution approved on December 18, 2014, your Honorable Board authorized the County of Westchester (the "County") to enter into a total of four (4) agreements, as specified below, (collectively, the "Agreements") pursuant to each of which the vendor specified below was to provide the Department of Social Services ("DSS") district office catchment area (each a "Zone") specified below with an Emergency Housing Assistance Program, consisting of the provision of Emergency Housing Units ("EHUs") and related housing service to customers deemed eligible for temporary housing assistance by DSS, for the not-to-exceed amount specified below, for the period from January 1, 2015 through December 31, 2016 (the "Initial Term"), with the County having the sole option to extend the term for up to three (3) additional one (1) year periods (each an "Option Term"):

Each of the Agreements was subsequently executed. The agreement with Westhab for the Peekskill District Office Zone (the "Peekskill Agreement") specified that it would provide 10 EHUs. The agreement with Westhab for the Yonkers District Office Zone (the "Yonkers Agreement") specified that it would provide 154 EHUs.

The Agreements resulted from a request for proposals ("RFP") that was issued in 2014. The RFP and each of the Agreements specified that the County might find, during the term of the Agreements, that the County requires more or fewer EHUs in a given Zone. Accordingly, the RFP and the Agreements contemplated that one or more of the agreements might have to be modified to reflect the need for more or fewer EHUs in a given Zone than originally anticipated.

The Department recently determined that more EHUs than anticipated are needed in the Peekskill District Office Zone and fewer EHUs than anticipated are needed in the Yonkers District Office Zone.

Accordingly, the County respectfully requests that your Honorable Board authorize the County to:

1.) Amend the Peekskill Agreement in order to, a.) modify its scope of work by increasing the number of EHUs to be provided from 10 to 15; b.) increase the not-to-exceed amount for the Initial Term and each Option Term, as specified below, in order to pay for the additional services being provided; and c.) modify its budget in order to reflect the changes necessitated by the modification to the scope of work:
