The 2015 Capital Budget contains funds for the above referenced project.

The work under this contract consists of providing all necessary labor, material and equipment required to replace the fuel storage tank leak monitoring system at the Central Maintenance Facility and to replace the paint booth breathing air system at the Cerrato Satellite Bus Facility.

The objective of this contract is to upgrade mechanical systems at the Central Maintenance Facility and the Cerrato Satellite Bus Facility.

This contract is in the public's best interest because it will allow the Department of Public Works and Transportation to upgrade regulated mechanical systems to current codes and standards, thus addressing the County Executive's priority area: Safety and Security (SS).

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

Payment for this entire contract will be made from New York State Dedicated Funds, not the County General Fund and will not impact the County tax levy.

RESOLVED, that adequate and sufficient security for the faithful performance of this contract shall be deemed to be receipt of a performance and payment bond in an amount equal to 100% of the total contract amount, and in a form approved by the County Attorney. The Bond Underwriter or Surety must appear on the U.S. Treasury's listing of approved sureties (Department Circular 570) and all Sureties must be licensed to transact business in New York as a surety company; and be it further

RESOLVED, that this advertisement for bids will state that pursuant to Chapter 308 of the Laws of the County of Westchester, the policy of the County is to encourage the meaningful and significant participation on County contracts for business enterprises owned by persons of color and women - Minority Business Enterprise (MBE) and Women Business Enterprise (WBE); and be it further
