RE: Authority to amend an agreement with the New York State Technology Enterprise Corporation to change the New York State Office of General Services ("NYSOGS") Contract Number from CMR524A to PN20500.

Authority is requested for the County of Westchester (the "County"), acting by and through the Department of Emergency Services (the "Department"), to amend its agreement with the New York State Technology Enterprise Corporation ("NYSTEC") for the provision of services to update the County's Interoperable Communications plans and tools (the "Agreement") in order to change the NYSOGS Contract Number from CMR524A to PN20500 for the period September 12, 2015 through December 2, 2015. All other terms and conditions of the Agreement shall remain the same and in full force and effect.

NYSTEC's contract with NYSOGS expired on September 11, 2015 and the County's contract with NYSTEC provided that the County's agreement with NYSTEC would continue through December 2, 2015 only if NYSTEC was able to renew its contract with NYSOGS. NYSTEC has advised that the NYSOGS contract has been renewed and that the new contract number is PN20500.

The goals and objectives of the agreement are to establish common planning and operational protocols and improve emergency responder skills and capabilities. The Department will track and monitor the goals and objectives of the agreement in order to evaluate the success of the program's impact on public safety and public health.

Approval of the attached resolution by your Honorable Board is respectfully requested.
