SUBJECT: Authority to, exercise the County's option to extend the term of an agreement with Atlantic Electric, Inc. for one two (2) year option period, thereby increasing the amount of the agreement by \$70,488.80 and extending the term of the agreement through December 1, 2017. (Contract No. 12-224)

By Resolution approved on September 27, 2012 (the "September 27th Resolution"), your Honorable Board awarded Contract No. 12-224 to Atlantic Electric, Inc. ("Atlantic Electric"). The September 27th Resolution authorized the County of Westchester (the "County") to enter into Contract No. 12-224 with Atlantic Electric, pursuant to which Atlantic Electric was to provide Service for Electrical Repairs, Various Locations, Westchester County, New York, for the amount of \$105,733.20, for the period from January 1, 2013 through December 31, 2015, ("Contract No. 12-224" or the "Agreement"), with the County having the sole option to extend the Agreement for one (1) two (2) year option period.

The County now seeks authority from your Honorable Board to exercise the two (2) year renewal option, and thereby, 1.) increase the amount of the Agreement by \$70,488.80 from an amount of \$105,733.20 to a new amount of \$176,222.00, and 2.) extend the termination date of the Agreement from December 31, 2015 to December 31, 2017.

All other terms and conditions of the September 27, 2012 Resolution and the Agreement shall remain in full force and effect and unchanged.

This contract is in the public's best interest because it will promote the health and safety of the general public by maintaining electrical systems at County facilities, thus addressing the County Executive's priority area: Safety & Security (SS).

As expenditures are made pursuant to this authorization, detailed records will be kept in the County's on-line financial system. These records will be easily accessible by Finance, Budget and department staff and will be reviewed regularly to ensure that funds are used appropriately.

RESOLVED, that the County is authorized to exercise its two (2) year renewal option for Contract 12-224 with Atlantic Electric, Inc., P.O. Box 59, Mahopac, New York 10541 for Service Contract for Electrical Repairs, Various Locations, Westchester County, New York, and thereby, a.) increasing the amount of the Agreement by \$70,488.80, from \$105,733.20 to \$176,222.00, and b.) extending the termination date of the Agreement from December 31, 2015 to December 31, 2017; and be it further

RESOLVED, that except as specifically amended hereby, all remaining terms and conditions of the September 27, 2012 Resolution and the Agreement shall remain in full force and effect and unchanged; and be it further

RESOLVED, that the County Executive or his duly authorized designee is hereby authorized to execute all documents and take all actions necessary to effectuate the purpose hereof.
