Re: **Resolution Authorizing the County of Westchester to enter into a Film Permit with Woodbridge Productions to authorize filming at the Westchester County Airport from September 9, 2015 through September 10, 2015 for a permit fee of \$20,825.**

Authority is requested for the County of Westchester, by and through its Office of Tourism & Film, to enter into a Film Permit with Woodbridge Productions (“Woodbridge”) in order to authorize Woodbridge to utilize the Westchester County Airport to film the television series “The Blacklist” from September 9, 2015 through September 10, 2015 for a permit fee of \$20,825. This request is being made because the film permit which authorizes a fee of \$20,825 to be paid to the County requires your Honorable Board’s approval. This film permit will provide revenue for the County and will also promote the County and promote local business.

This agreement will serve a public purpose by encouraging film production in Westchester County and will result in local economic development as well. The goal of providing Westchester County locations for films and commercial photography will be monitored by the Westchester County Office of Tourism & Film. Your Honorable Board’s approval of this Film Permit will increase film permit revenues to the County.

For all the foregoing reasons, a resolution authorizing a Film Permit with Woodbridge Productions is attached for your Honorable Board’s approval.
