Re: Authority to enter into affiliation agreements with (i) Cortlandt Regional Paramedics; (ii) Peekskill Volunteer Ambulance Corps; (iii) Mohegan Lake Volunteer Ambulance Corps; and (iv) Cortlandt Community Volunteer Ambulance Corps for clinical education and instruction of students in the EMS/Paramedic Program.

Included in the programs offered by Westchester Community College (the "College") is an EMS/Paramedic program. The College offers supervised clinical education and instruction for matriculated Westchester Community College students who are pursuing a degree or certificate in this program in conjunction with various organizations. Attached is a resolution that would authorize the College to enter into agreements commencing on January 1, 2016 and terminating on December 31, 2020 for assistance in providing this instruction with the following organizations:

1. Cortlandt Regional Paramedics;
2. Peekskill Volunteer Ambulance Corps;
3. Mohegan Lake Volunteer Ambulance Corps; and
4. Cortlandt Community Volunteer Ambulance Corps

There will be no cost to the College, but the parties will cross indemnify each other for their respective negligence.

I believe that it is in the best interest of the College to provide clinical education and instruction programs; and I therefore, recommend that you act favorably on the annexed proposed resolution.

Upon a communication from the President of Westchester Community College, be it hereby

RESOLVED, that the County of Westchester acting by and through Westchester Community College is hereby authorized to enter into affiliation agreements commencing on January 1, 2016 and terminating on December 31, 2020 with the following organizations pursuant to which the institutions shall provide, in conjunction with but at no cost to the County, a supervised clinical education and instruction program for matriculated Westchester Community College students who are pursuing a degree or certificate program of study in the EMS/Paramedic program:

1. Cortlandt Regional Paramedics;
2. Peekskill Volunteer Ambulance Corps;
3. Mohegan Lake Volunteer Ambulance Corps; and
4. Cortlandt Community Volunteer Ambulance Corps

RESOLVED, there will be no cost to the College, but the parties will cross indemnify each other for their respective negligence; and be it further

RESOLVED, that the County Executive or his authorized designee is hereby authorized to execute all instruments and take all actions reasonably necessary to implement this Resolution.
