Port Chester, New York

By Resolution approved on April 11, 2013 your Honorable Board awarded Contract No. 12-528 for Rotating Biological Contactors Upgrade – Phase I, Port Chester Wastewater Treatment Plant, Port Chester, New York to Yonkers Contracting Company, Inc. in the amount of \$2,577,000.00, for the period from April 25, 2013 through May 24, 2015. The Contract was subsequently executed.

By Resolution approved on March 13, 2014, your Honorable Board approved Change Order No. 1 to Contract No. 12-528 in the amount of \$875,000.00, and extended the contract period through December 31, 2015.

Contract completion is delayed due to construction issues. Therefore, the County now seeks authority from your Honorable Board to amend the March 13, 2014 Resolution budget box end date from December 31, 2015 to December 31, 2016.

All other terms and conditions of the March 13, 2014 Resolution and the Contract shall remain in full force and effect and unchanged.
