Re: Authority for the County of Westchester, acting by and through Westchester Community College, to enter into an agreement with the Yonkers Public Schools, acting by and through its Board of Education for programs at Gorton, Riverside and Saunders Trade and Technical High Schools.

Westchester Community College (the "College") and The Yonkers Public Schools, acting by and through its Board of Education (the "Yonkers Public Schools"), have collaborated on a number of programs over the years whereby the College has provided instructors and instructional material to the Yonkers Public Schools for the benefit of high school students.

Authority is requested to authorize the County of Westchester, acting by and through the College, to enter into an agreement with the Yonkers Public Schools whereby the College will provide (i.) instructional support and the opportunity to earn college credits to Gorton High School students; and (ii.) professional development to English, Mathematics, Electrical Engineering, Cybersecurity and Architecture/Civil Engineering teachers of Riverside High School and Saunders Trade and Technical High School. The proposed agreement will have a term commencing August 1, 2015 and terminating August 31, 2016. The Yonkers Public Schools will pay to the College an amount not to exceed \$159,818 for providing these services. The College will defend and indemnify the Yonkers Public Schools for the College's willful misconduct or negligent performance or failure to perform.

This agreement is exempt from the operation of the Westchester County Procurement Policy pursuant to Section 3(a)(iii) in that it is an agreement with a political subdivision of the State of New York. The agreement is authorized pursuant to Section 6306.8 of the

Education Law in that it is an agreement for a cooperative educational program with a school district

Accordingly, I recommend adoption of the attached resolution.

RESOLVED, that the County of Westchester, acting by and through Westchester Community College, is authorized to enter into an agreement with the Yonkers Public Schools, acting by and through its Board of Education for programs at Gorton, Riverside and Saunders Trade and Technical High Schools; and be it further

RESOLVED, that the proposed agreement will have a term commencing August 1, 2015 and terminating August 31, 2016. The Yonkers Public Schools will pay to the College an amount not to exceed \$159,818 for providing these services. The College will defend and indemnify the Yonkers Public Schools for the College's willful misconduct or negligent performance or failure to perform; and be it further

RESOLVED, that the County Executive or his duly authorized designee be and hereby is authorized and empowered to execute any and all instruments and to take all action necessary to implement the purposes hereof.
