Re: Authority for the County of Westchester, acting by and through Westchester Community College, to enter into an agreement with the Yonkers Public Schools, acting by and through its Board of Education for the Advanced College Experience program at Roosevelt High Schools.

Westchester Community College (the "College") and The Yonkers Public Schools, acting by and through its Board of Education (the "Yonkers Public Schools"), have collaborated on a number of programs over the years that have benefited both students and instructors from the Yonkers Public Schools.

Authority is requested to authorize the County of Westchester, acting by and through the College, to enter into an agreement with the Yonkers Public Schools whereby the College will provide college-level courses under its Advanced College Experience program to students at Roosevelt High School. The proposed agreement will have a term commencing October 1, 2015 and terminating July 31, 2016. The Yonkers Public Schools will pay to the College an amount not to exceed \$44,772.50 for providing these services. The College will defend and indemnify the Yonkers Public Schools for the College's willful misconduct or negligent performance or failure to perform.

This agreement is exempt from the operation of the Westchester County Procurement Policy pursuant to Section 3(a)(iii) in that it is an agreement with a political subdivision of the State of New York. The agreement is authorized pursuant to Section 6306.8 of the Education Law in that it is an agreement for a cooperative educational program with a school district

Accordingly, I recommend adoption of the attached resolution.

RESOLUTION

Upon a communication from the President of Westchester Community College, be it hereby:

RESOLVED, that the County of Westchester, acting by and through Westchester Community College, is authorized to enter into an agreement with the Yonkers Public Schools, acting by and through its Board of Education whereby the College will provide college-level courses under its Advanced College Experience program to students at Roosevelt High School; and be it further

RESOLVED, that the proposed agreement will have a term commencing October 1, 2015 and terminating July 31, 2016. The Yonkers Public Schools will pay to the College an amount not to exceed \$44,772.50 for providing these services. The College will defend and indemnify the Yonkers Public Schools for the College's willful misconduct or negligent performance or failure to perform; and be it further

RESOLVED, that the County Executive or his duly authorized designee be and hereby is authorized and empowered to execute any and all instruments and to take all action necessary to implement the purposes hereof.
