Authority to Amend a Resolution approved on November 24, 2015 which Re:

authorized the County to Advertise for the purpose of Soliciting Bids for a Contract to provide Non-Emergency Moving and Storage Services within Westchester County for Households Eligible for Temporary Housing, by changing the term of the proposed Agreement from a term of two-years with the County having an option to extend the contract for two (2) additional one-year periods, to a term of only one-year with the County having an option to extend the contract for up to three (3) additional one-year periods.

By resolution approved on November 24, 2015 (the "November 24<sup>th</sup> resolution"), your Honorable Board authorized the County of Westchester (the "County"), through its Department of Social Services (the "Department"), to solicit bids by public advertisement for a contract for the provision of Non-Emergency Moving and Storage Services for *planned* "non-emergency" moves of households eligible for temporary housing within Westchester County, as well as storage services, for a two-year period, with the County having an option to extend the contract for two additional one-year periods.

The November 24<sup>th</sup> Resolution further provided that bid security in the form of a check for \$1,000 would be required, and that adequate and sufficient security for the full and faithful performance of the contract would be receipt of cash, certified check, irrevocable letter of credit, or performance and payment bond in the amount of 5% of the total annual contract amount and in a form approved by the County Attorney. In addition, the November 24th resolution provided that such advertisement for bids would appear in The Journal News (Westchester-Putnam

Edition) on the Empire State Purchasing Group Website and the Westchester County Government Website (Business Opportunities). Lastly, the November 24<sup>th</sup> Resolution provided that the advertisement for bids would state that pursuant to Chapter 308 of the Laws of the County of Westchester, the policy of the County is to encourage the meaningful and significant participation on County contracts for business enterprises owned by persons of color and women – Minority Business Enterprise (MBE) and Women Business Enterprise (WBE). The Department has not yet advertised for bids for this project.

The Department recently instituted a policy prohibiting multi-year agreements. The November 24<sup>th</sup> Resolution authorized the County to advertise for a multi-year agreement by providing for an initial term of two years. Accordingly, authority is now requested to amend the November 24<sup>th</sup> Resolution for the limited purpose of changing the term of the proposed Agreement for which authority to advertise is being sought, from two-years, with the County having an option to extend the contract for two (2) additional one-year periods, to a term of only one-year, with the County having an option to extend the contract for up to three (3) additional one-year periods.

Except as otherwise specifically amended hereby, all remaining terms and conditions set forth in the November 24<sup>th</sup> Resolution shall remain in full force and effect.

I most respectfully ecommend the adoption of the attached resolution.
