On August 26, 2015, four (4) bids were received and opened for Contract No. 10-530 for Roadway and Related Improvements, Greenwich Road (C.R. #12), from Millbrook Road to Route 172, a Distance of 1.5 Miles, Town of Bedford, New York.

All bids exceeded the amount budgeted for this project. The department is reviewing the contract documents to reduce the overall scope of work in order to reduce costs.

Therefore, it is requested that all bids be rejected and re-advertised as Contract 10-530-Rev.

The objective of this contract is to replace substandard areas of asphalt pavement.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that Greenwich Road meets current codes and standards as well as reducing the County's annual maintenance costs.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

This Resolution has been reviewed by the Law Department.

Upon communication from the Commissioner of Public Works and Transportation,

**WHEREAS**, on August 26, 2015, four (4) bids were received and opened for Contract No. 10-530 for Roadway and Related Improvements, Greenwich Road (C.R. #12), from Millbrook Road to Route 172, a Distance of 1.5 Miles, Town of Bedford, New York; and

**WHEREAS**, it has been determined that all bids exceeded the amount budgeted for this project, and therefore, the Department of Public Works and Transportation is reviewing the contract documents to reduce the overall scope of work in order to reduce costs; and

**WHEREAS**, it is hereby requested that all bids received for Contract No. 10-530 be rejected and the contract be re-advertised as Contract No. 10-530-Rev.; now, therefore, be it

**RESOLVED**, that the bids for Contract No. 10-530 for Roadway and Related Improvements, Greenwich Road (C.R. #12), from Millbrook Road to Route 172, a Distance of 1.5 Miles, Town of Bedford, New York be rejected; and be it further

**RESOLVED**, that it is in the best interest of the County that Contract No. 10-530 for Roadway and Related Improvements, Greenwich Road (C.R. #12), from Millbrook Road to Route 172, a Distance of 1.5 Miles, Town of Bedford, New York, be re-advertised as Contract No. 10-530-Rev. for Roadway and Related Improvements, Greenwich Road (C.R. #12), from Millbrook Road to Route 172, a Distance of 1.5 Miles, Town of Bedford, New York; and be it further

**RESOLVED**, that adequate and sufficient security for the faithful performance of this contract shall be deemed to be receipt of a performance and payment bond in an amount equal to 100% of the total contract amount, and in a form approved by the County Attorney. The Bond Underwriter or Surety must appear on the U.S. Treasury's listing of approved sureties (Department Circular 570) and all Sureties must be licensed to transact business in New York as a surety company; and be it further

**RESOLVED**, that this advertisement for bids will state that pursuant to Chapter 308 of the Laws of the County of Westchester, the policy of the County is to encourage the meaningful and significant participation on County contracts for business enterprises owned by persons of color and women - Minority Business Enterprise (MBE) and Women Business Enterprise (WBE); and be it further
