On February 17, 2016, eight (8) bids were received and opened for Contract No. 15-538 for Roadway Resurfacing and Related Improvements, West Lake Drive (C.R. #144), from Columbus Avenue to North Kensico Avenue, a Distance of 0.74 Miles, Town of Mount Pleasant, New York.

The bids were reviewed by the Department and it was determined that Montesano Brothers, Inc. submitted the low bid in the amount of \$776,117.00.

The low bidder has been investigated and it has been found that Montesano Brothers, Inc.:

- Performed satisfactory work in the past for the County  
 Past experience has been investigated and found satisfactory

The objective of this contract is to replace substandard areas of asphalt paving.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that West Lake Drive meets current codes and standards as well as reducing the County's annual maintenance costs.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 15-538 be awarded to Montesano Brothers, Inc. in the amount of \$776,117.00.
