**Resolution to extend a contract with Crescent Contracting Corp. (the "Contract")  
for an additional two-year term commencing April 1, 2016**

A resolution was approved by the Board of Acquisition and Contract on 03/20/2014 that authorized DEF to enter into a contract with Crescent Contracting Corp. ("Crescent"), for Boiler Maintenance and Repairs at various locations of the Department of Environmental Facilities (Locations as follows: Blind Brook WWTP, Mamaroneck WWTP, New Rochelle WWTP, Ossining WWTP, Hutchinson Pump Station, North Yonkers Pump Station, Yorktown Garage and the Sprout Brook Disposal Facility).

The original Contract duration was two years with an option to extend for an additional two year term upon the mutual consent of the parties. During the term of the original contract, Crescent has provided satisfactory service to the County and is willing to consent to the extension. Accordingly, authority is requested to exercise the County's option to extend the Crescent contract for the additional two-year period in the amount of \$262,440.00, as provided for in the original bid document.

The work required in this contract, performing yearly maintenance and on-call services, requires trained service personnel who have the background, experience and knowledge to work on the various types of boilers at County facilities. There are a total of 13 boilers in seven locations including radiant, and unit heaters at two locations that are to be maintained as part of this contract. Performing yearly preventive maintenance service on the boilers is important to maintain the equipment in peak operating condition.

The goals and objectives of the contract are to obtain services which will allow the Department to service and maintain all boilers, and heaters at four (4) wastewater treatment plants, two (2) pump stations, the Yorktown Garage and the Sprout Brook Facility assuring proper operation and safety, and to function properly at design efficiency with minimal breakdowns. During the two year term of the contract, Department representatives will track and monitor the required preventive maintenance, and necessary repairs using written service reports which will be signed by Maintenance Superintendents. These service reports are to be submitted with each payment request. The Contractor will be responsible to comply with all applicable regulations and codes.

Issuing a contract for preventive maintenance is fiscally responsible because it will ensure the boilers are operating at their optimum levels, with no leaks or wasted energy inputs. Having qualified service personnel check the units at regular intervals will reduce the likelihood of needing emergency repairs, which are more costly than preventive maintenance services. In addition to lowering operating costs, regular maintenance has been proven to extend the overall life of the equipment, thereby pushing replacement costs further into the future. The boilers supply heat to buildings and equipment systems throughout the plant so it is vitally important to regularly maintain this infrastructure. If plant heating is interrupted, there is potential for pipes freezing and other problems that are costly to repair.

This Contract is deemed to fulfill a public purpose as the services provided under this contract protect the building and facilities owned by the Department of Environmental Facilities and enable the Department to carry out its basic mission to provide wastewater treatment and maintain satisfactory water quality. The term of this contract is for a period of two (2) consecutive years, subject to appropriations.

Approval of the attached resolution is respectfully requested.

# RESOLUTION

Upon a communication from the Commissioner of Environmental Facilities, be it hereby

**RESOLVED:** the resolution dated February 20, 2014 awarding contract EF-1312 to Crescent Contracting Corp. (the "Contract") for Boiler Maintenance and Repairs at four (4) wastewater treatment plants, two (2) pump stations, the Yorktown Garage and the Sprout Brook Facility in Westchester County for a two-year period is hereby amended to include the extension of the Agreement by mutual consent of the Contractor and the County of Westchester for an additional two-year period commencing April 1, 2016 at a cost not to exceed \$262,440.00 as provided in the bid document ; and be it further

**RESOLVED:** All other terms and conditions of the Contract shall remain the same; and be it further

**RESOLVED:** that this contract extension is subject to annual appropriations; and be it further

**RESOLVED:** that this Agreement is also subject to further financial analysis of the impact of any New York State Budget (the "State Budget") proposed and adopted during the term of this Agreement. The County shall retain the right, upon the occurrence of any release by the Governor of a proposed budget of the State of New York and/or the adoption of the State Budget or any amendments thereto, and after the County has a reasonable period of time after such release(s) or adoption(s), to conduct an analysis of the impacts of such State Budget on County finances. After such analysis, the County shall retain the right to either terminate this Agreement or to renegotiate the amounts and rates approved herein. If the County subsequently offers to pay a reduced amount to the Contractor, then such Contractor shall have the right to terminate this Agreement upon reasonable prior written notice; and be it further

**RESOLVED:** that the County Executive or his duly authorized designee is hereby authorized to execute any and all instruments and take all actions necessary to accomplish the purpose hereof.
