RE: First Amendment to Contract No. **EF-1511**
Authorization to extend the term of Agreement between the County of Westchester and Mace Contracting Corporation until November 30, 2016 at no additional cost.

On December 7, 2015, Contract No. EF-1511 was executed between the County of Westchester and, Mace Contracting Corporation ("Mace") for the modifications to the south control structure at the Yonkers Joint Wastewater Treatment Plant, Westchester County, New York, in the amount of \$183,000.00. The contract duration was originally for a term of six (6) months, beginning on December 14, 2015 and ending on June 10, 2016.

The County has been satisfied with the quality of services provided to date. An extension of time is being requested because the hatches that were supplied were not the correct size, thus delaying the project until new hatches can be fabricated, delivered and installed. The attached Resolution for Amendment No. 1 has been prepared to extend the contract end date and will provide the Contractor additional time to complete all the contract work.

The attached resolution is requesting for an extension of the agreement until November 30, 2016, with no increase in the not to exceed amount of \$183,000.00. The time extension is requested, for the provision of completing all the required contract work in connection with the modifications to the South Control Structure with no additional cost.

The intent of this amendment is to allow the Contractor sufficient time to complete the entire scope of contract work. Department representatives will continue to track and monitor the Contractor's work and verify the work is in accordance with the contract documents. This Contract is deemed to fulfill a public purpose as the services provided under this Contract protect the building and facilities owned by the Department of Environmental Facilities and enable the Department to carry out its basic mission to provide wastewater treatment and maintain satisfactory water quality.

Approval by the Board of Acquisition and Contract is respectfully requested.

RESOLVED, That County of Westchester, acting by and through its Department of Environmental Facilities, ("County") be and is hereby authorized to amend Agreement No. EF-1511 with Mace Contracting Corporation, 35 Portman Road, New Rochelle, NY 10801, for modifications to the south control structure Yonkers Joint Wastewater Treatment Plant, Yonkers, New York, by extending the term until November 30, 2016; and be it further

RESOLVED, that the County Executive or his duly authorized designee is hereby authorized and empowered to execute any and all documents necessary or appropriate to effectuate the purposes hereof.
