Authority is requested for the County of Westchester, by and through its Office of Tourism & Film, to enter into a Film Permit with Picrow, Inc. ("Picrow") in order to authorize Picrow to utilize the Playland Park to film the television show currently titled "Red Oaks" for Amazon Studios from July 7, 2016 through July 9, 2016 for a permit fee of \$24,331.06. This request is being made because the film permit which authorizes a fee of \$24,331.06 to be paid to the County requires your Honorable Board's approval. This film permit will provide revenue for the County and will also promote the County and promote local business.

This agreement will serve a public purpose by encouraging film production in Westchester County and will result in local economic development as well. The goal of providing Westchester County locations for films and commercial photography will be monitored by the Westchester County Office of Tourism & Film. Your Honorable Board's approval of this Film Permit will increase film permit revenues to the County.

For all the foregoing reasons, a resolution authorizing a Film Permit with Picrow, Inc. is attached for your Honorable Board's approval.
