On June 29, 2016, six (6) bids were received and opened for Contract No. 14-503 for Primary Sludge Pumping System Improvements, Mamaroneck Wastewater Treatment Plant, Mamaroneck, New York.

The bids were reviewed by the Department and it was determined that The Halcyon Construction Corp. submitted the low bid in the amount of \$1,114,896.00, and has proposed the utilization of the following subcontractor: Solar Electric Systems Inc. (Electrical Work), 2 Tibbits Avenue, White Plains, New York 10606.

The low bidder has been investigated and it has been found that The Halcyon Construction Corp.:

- Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

The objective of this contract is to allow the Department of Environmental Facilities to maintain its treatment plant systems and to ensure continuous and reliable processing of sludge.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring continued uninterrupted operation of the plant's wastewater treatment systems. The project will enable the Department of Environmental Facilities to carry out its basic mission to provide wastewater treatment and maintain satisfactory water quality.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 14-503 be awarded to The Halcyon Construction Corp. in the amount of \$1,114,896.00.
