On June 8, 2016, nine (9) bids were received and opened for Contract No. 16-504 for Stormwater Management Upgrade, Westchester County Airport, Towns of Harrison and North Castle and Village of Rye Brook, New York.

The bids were reviewed by the Department and it was determined that R. Pugni & Sons, Inc. submitted the low bid in the amount of \$2,801,257.50.

The low bidder has been investigated and it has been found that R. Pugni & Sons, Inc.:

The objective of this contract is to increase the available amount of water detention on the Airport and improve water quality.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that the Airport's detention basins meet all current codes and standards.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

Payment for this entire contract will be made from Federal Aviation Administration Funds, New York State Funds and the Airport Special Revenue Fund, not the County General Fund and will not impact the County tax levy.

It is my recommendation that Contract No. 16-504 be awarded to R. Pugni & Sons, Inc. in the amount of \$2,801,257.50.
