Re: Authority for the County of Westchester, acting by and through Westchester Community College, to enter into an agreement with the Yonkers Public Schools, acting by and through its Board of Education for the rental of classroom space at Roosevelt High School.

Attached is a resolution that would authorize the County of Westchester, acting by and through Westchester Community College (the "College"), to enter into an agreement with the Yonkers Public Schools, acting by and through its Board of Education ("Yonkers Public Schools") for the rental of classroom space at Roosevelt High School for an Adult Education Program.

The proposed agreement will have a term commencing September 1, 2016 and terminating May 31, 2017. The Yonkers Public Schools will be paid an amount not to exceed \$50,000 for the use of classrooms and as payment for ancillary services that may be needed, pursuant to an approved budget. The College will defend and indemnify the Yonkers Public Schools for the College's willful misconduct or negligent performance or failure to perform.

Section 6306(8) of the Education Law authorizes community colleges to participate in cooperative educational programs, services and arrangements with school districts. In addition, this license agreement is exempt from the Westchester County Procurement Policies and Procedures pursuant to Section 3(b) thereof.

Accordingly, I recommend adoption of the attached resolution.

**RESOLVED**, that the County of Westchester, acting by and through Westchester Community College, is authorized to enter into an agreement with the Yonkers Public Schools, acting by and through its Board of Education for the rental of classroom space at Roosevelt High School for an Adult Education Program; and be it further

**RESOLVED**, that the proposed agreement will have a term commencing September 1, 2016 and terminating May 31, 2017. The Yonkers Public Schools will be paid an amount not to exceed \$50,000 for the use of classrooms and as payment for ancillary services that may be needed, pursuant to an approved budget. The College will defend and indemnify the Yonkers Public Schools for the College's willful misconduct or negligent performance or failure to perform; and be it further

**RESOLVED**, that the County Executive or his duly authorized designee be and hereby is authorized and empowered to execute any and all instruments and to take all action necessary to implement the purposes hereof.
