RE: **A.) AUTHORITY TO ENTER INTO AN AGREEMENT WITH THE NEW YORK STATE OFFICE OF CHILDREN AND FAMILY SERVICES TO ACCEPT FUNDS IN AN AMOUNT NOT TO EXCEED \$606,339 TO MEET THE COUNTY'S OBLIGATIONS UNDER THE SUPERVISION AND TREATMENT SERVICES FOR JUVENILES PROGRAM (STSJP) FOR THE PERIOD OF OCTOBER 1, 2016 TO SEPTEMBER 30, 2017.**

**B.) AUTHORITY TO SIGN AN AGREEMENT WITH WESTCHESTER JEWISH COMMUNITY SERVICES TO OPERATE THE LINKAGES PROGRAM IN AN AMOUNT NOT TO EXCEED \$191,339 FOR THE PERIOD OCTOBER 1, 2016 TO SEPTEMBER 30, 2017.**

The County of Westchester (the "County"), acting by and through the Department of Probation (the "Department"), seeks authority from your Honorable Board to enter into an agreement with the New York State Office of Children and Family Services (NYOCFS) to accept funding in the amount of \$606,339.00 to meet the County's obligations under the Supervision and Treatment Services for Juveniles Program (STSJP) for the period October 1, 2016 to September 30, 2017.

Authority is also requested to sign an agreement with Westchester Jewish Community Services (WJCS) whereby WJCS will operate the Linkages Program in an amount not to exceed \$191,339, as set forth below, for the period October 1, 2016 to September 30, 2017.

The remaining \$415,000 will be allocated as follows:

Under the agreement Westchester Jewish Community Services operates the Linkages program. The Linkages Program consists of assessment services for youth who have been arrested for juvenile delinquency offense and whose cases are deemed appropriate for adjustment services. Additionally, Linkages may also do assessments on court ordered PINS Diversion cases when appropriate. Westchester County Department of Probation remains responsible for case planning and case management. Linkages will make every effort to engage families in the adjustment process to conduct assessments and provide diversion services and referrals as well as outreach to the victims. Assessments consist of clinical as well as YASI evaluations. The program was designed to serve JDs who had received appearance tickets in Westchester County. The Linkages program served 124 youth from October 1, 2015 through September 30, 2016.

The Department operated the Probation Juvenile Accountability Program which served youth throughout Westchester County. The youth in this program were Persons In Need of Supervision (PINS) and JDs who had been adjudicated or were awaiting disposition from court on a case. The Juvenile Accountability Probation program serves approximately 300 youth in a year, 2,500 PINS contacts and 4,000 JD contacts. Contacts include but are not limited to face to face meetings in field, school, or phone.

The Department oversees an Alternative to Detention (ATD) program where juveniles step down from secure and non-secure detention to the ATD program as they transition to community based supervision.

Lastly, the Department oversees court ordered mental health clinical evaluations for juveniles remanded to secure and non-secure detention. These clinical evaluations assist the courts in determining dispositions for these juveniles.

The outcomes were measured quarterly through collection and review of data submitted to the Chief of Planning, Research and Staff Development for the Department of Probation.

The public purpose of this contract is to prevent future delinquency, including youth violence, by working with youth before they commit a crime or engage in other delinquent behaviors. By providing services in the community, youth can stay at home with their families and continue to go to school, while still getting their needs met and saving taxpayers money.

The agreement to accept State funding under the STSJP Program is exempt from the Westchester County Procurement Policy under Section 3(a)iii because it is a contract with the State of New York. The agreement with Westchester Jewish Community Services is exempt from the Westchester County Procurement Policy under Section 3(a)xviii because it is a contract for the “...creation and support of youth service projects and appropriate programs and services for the prevention of delinquency and youth crime...”
