RE: AUTHORITY FOR THE COUNTY OF WESTCHESTER TO ENTER INTO AN AGREEMENT

> WITH THE NEW YORK STATE DEPARTMENT OF TRANSPORTATION FOR REIMBURSEMENT OF \$560,000 OF THE COSTS INCURRED FOR THE WESTCHESTER COUNTY SMART COMMUTE PROGRAM DURING THE TERM

COMMENCING JANUARY 1/2016 AND ENDING DECEMBER 31, 2016

(Agreement No. DOTSMRV16-01; NYS Agreement No. D035227)

Authority is requested for the County of Westchester to enter into an agreement with the New York State Department of Transportation for reimbursement of \$560,000.00 of the \$700,000.00 cost of the Westchester County SMART Commute Program, under the Federal Congestion Mitigation and Air Quality Program (CMAQ) for the period January 1, 2016 through December 31, 2016.

The agreement will reimburse \$560,000.00 of the total cost of the program, with the \$140,000.00 local share funded in the 2016 Department of Public Works and Transportation Operating Budget Advance to Grants Account 101-44-1000-4912.

The SMART Commute Program provides for: the maintenance and production of Bee-Line bus schedules, the continuation of a network of local sales outlets for MetroCards, an extensive program of outreach events at employment centers, County support for various carpool, vanpool and tax-free employer transit benefit programs, electronic distribution of monthly transit information bulletins and emergency transit service and advertising for Bee-Line and other congestion mitigation and air quality transportation nitiatives.

The goal of the County's SMART Commute Program is to encourage the use of alternatives to drive- alone commuting. The program serves the interest of public health by encouraging the use of transit rather than single-occupant vehicles, and is part of the regional travel demand program which receives emission reduction credits from the US Environmental Protection Agency. The objective of this contract is to fund that program with non-County money, which is fiscally responsible.

This program will be monitored by the Department of Public Works and Transportation with routine reporting as required by the New York State Department of Transportation.

RESOLUTION

Upon a communication from the Commissioner of Public Works and Transportation, be it hereby

RESOLVED, that the County of Westchester is authorized to enter into an agreement with the New York State Department of Transportation for an amount not to exceed \$700,000.00 for administration of the SMART Commute Program for the period January 1, 2016 through December 31, 2016; and be it further

RESOLVED, that under this agreement the State of New York will provide up to \$560,000.00 in Federal funds to the County of Westchester and the County of Westchester will provide matching funds up to \$140,000.00; and be it further

RESOLVED, that the County Executive or his duly authorized designee is hereby authorized and empowered to execute any documents and take any action reasonably necessary and appropriate to effectuate the purposes of this Resolution.
