The 2017 Capital Budget contains funds for the above referenced project.

The work under this contract consists of providing all necessary labor, material and equipment required for restoration and stabilization of the existing terrace garden wall as well as the rehabilitation and addition of asphalt trails throughout the garden. In addition, the entrance drive will be resurfaced, the dirt parking lot will be paved with porous asphalt and ancillary curbing, and guiderail and drainage will be added. Site furniture installation, parking lot lighting, fencing and landscaping improvements will also be included.

The objective of this contract is to upgrade structural elements, pathways and the parking lot at Lenoir Park.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that structural elements, pathways and the parking lot at Lenoir Park meet current codes and standards as well as reducing the County's annual maintenance costs.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

The Bond Underwriter or Surety must appear on the U.S. Treasury's listing of approved sureties (Department Circular 570) and all Sureties must be licensed to transact business in New York as a surety company; and be it further

RESOLVED, that this advertisement for bids will state that pursuant to Chapter 308 of the Laws of the County of Westchester, the policy of the County is to encourage the meaningful and significant participation on County contracts for business enterprises owned by persons of color and women - Minority Business Enterprise (MBE) and Women Business Enterprise (WBE); and be it further
