RE: Authority to enter into an agreement with Oneil Bennett, Park Foreman, Willson's Woods Park, for the County-owned residence at Willson's Woods Park, Mount Vernon, New York, in accordance with the formula for the licensing of County residences from May 1, 2017 through May 31, 2021.

Authority is hereby requested for the County of Westchester, acting by and through the Department of Parks, Recreation and Conservation, to enter into an agreement with Oneil Bennet, Park Foreman, Willson's Woods Park, for the County-owned residence at Willson's Woods Park, located at 8 Bradford Avenue, Mount Vernon, New York from May 1, 2017 through May 31, 2021 with an annual increase of two percent commencing June 1, 2018.

As a privilege of living in this County-owned residence, the license fees shall be:

The ultimate goal of these agreements will be for the public good by providing employees in County-owned park facilities to provide a security presence while at the same time providing revenue to the County. The agreement promotes fiscal responsibility as the County will benefit from the revenue from the license agreements. The objective of this agreement is to allow for the continued presence of County employees on park property and will be tracked and monitored by site visits by Department of Parks, Recreation and Conservation staff.

Accordingly, approval of the attached resolution by your Honorable Board is most respectfully requested.

This agreement is exempt from the Westchester County procurement policy pursuant to Section 3(b), thereof.
