On March 17, 2017, five (5) bids were received and opened for Contract No. 15-505 for Roadway Resurfacing and Additional Improvements, North Street (C.R. #73), from Harrison Avenue to Boston Post Road, and Hammond Road (C.R. #73), from North Street to Theodore Fremd Avenue, a Distance of 1.90 Miles, Town of Harrison and City of Rye, New York.

The bids were reviewed by the Department and it was determined that Bilotta Construction Corp. submitted the low bid in the amount of \$2,123,083.50.

The low bidder has been investigated and it has been found that Bilotta Construction Corp.:

- Performed satisfactory work in the past for the County
 Past experience has been investigated and found satisfactory

The objective of this contract is to replace substandard areas of asphalt paving.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that North Street and Hammond Road meet current codes and standards as well as reducing the County's annual maintenance costs.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 15-505 be awarded to Bilotta Construction Corp. in the amount of \$2,123,083.50.
