The objective of this contract is to repair substandard structural elements of the Matthews Mill Road Bridge.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that the Matthews Mill Road Bridge meets current codes and standards as well as reducing the County's annual maintenance costs.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.
