On April 12, 2017, nine (9) bids were received and opened for Contract No. 15-512 for Resurfacing and Related Improvements, Bloomer Road (C.R. #39), from June Road to Peach Lake Road, a Distance of 1.37 Miles, Town of North Salem, New York.

The bids were reviewed by the Department and it was determined that ELQ Industries, Inc. submitted the low bid in the amount of \$1,618,907.75.

The low bidder has been investigated and it has been found that ELQ Industries, Inc.:

- Performed satisfactory work in the past for the County  
 Past experience has been investigated and found satisfactory

The objective of this contract is to replace substandard areas of asphalt paving.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that Bloomer Road meets current codes and standards as well as reducing the County's annual maintenance costs.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 15-512 be awarded to ELQ Industries, Inc. in the amount of \$1,618,907.75.
