On May 10, 2017, nine (e) bids were received and opened for Contract No. 14-500 for Roadway and Drainage Improvements, Wilmot Road (C.R. #113), from Old Wilmot Road (North) to Old Wilmot Road (South), a Distance of 0.35 Miles, Town of Eastchester, New York.

The bids were reviewed by the Department and it was determined that MVM Construction LLC submitted the low bid in the amount of \$813,000.00.

The low bidder has been investigated and it has been found that MVM Construction LLC:

Performed satisfactory work in the past for the County.
