Re: Authority for the County of Westchester, acting by and through Westchester Community College, to amend an agreement with the Yonkers Public Schools, acting by and through its Board of Education whereby the College will provide the Early College Experience program in order to add additional services at Gorton High School and to increase the not to exceed amount of the agreement by \$15,217.

The County of Westchester, acting by and through Westchester Community College (the "College") and The Yonkers Public Schools, acting by and through its Board of Education (the "Yonkers Public Schools"), have collaborated on a number of programs over the years whereby the College has provided instructors and instructional material to the Yonkers Public Schools for the benefit of their students.

On February 10, 2017, your Honorable Board authorized the College to enter into an agreement with the Yonkers Public Schools whereby the College would provide college-level courses under its Early College Experience program to students at Roosevelt High School, having a term commencing October 1, 2016 and terminating August 31, 2017, pursuant to which the Yonkers Public Schools would pay to the College an amount not to exceed \$43,320 for providing these services. In addition, the College agreed to defend and indemnify the Yonkers Public Schools for the College's willful misconduct or negligent performance or failure to perform. The agreement was subsequently executed.

Authority is now requested to amend the agreement in order for the College to provide the Early College Experience Program to students at Gorton High School. The College will be paid an additional amount not to exceed \$15,217 for providing this program, resulting in a new total not to exceed amount payable for the agreement of \$58,537.

All other terms and conditions of the Agreement will remain the same.
Accordingly, I recommend adoption of the attached resolution.
