Authority is requested to enter into an agreement with the New York State Department of Transportation for the receipt of \$1,203,250.00 in Mass Transportation capital projects funds. The revenue from the New York State grant will be credited to the following projects:

RESOLVED, that the County Executive or his duly authorized designee be and hereby is authorized to execute any and all documents necessary and appropriate to effectuate the purposes hereof.
