SUBJECT: Authority to:

- 1.) Enter into an agreement with the United States Department of Housing and Urban Development in order to accept a grant in the amount of \$148,788.00 under its Continuum of Care program, to be used to pay for a leasing project that will provide seven (7) units of housing for homeless persons with chemical dependency or co-occurring (mental health/chemical dependency) disorders, for the period from December 1, 2017 through November 30, 2018; and
- 2.) Enter into a sub-grant agreement with The Guidance Center of Westchester, Inc., pursuant to which it will provide services for the operation and management of the above-described leasing project, for the period from December 1, 2017 through November 30, 2018, for a sub-grant amount not-to-exceed \$145,659.00.

Authority is requested for the County of Westchester (the "County") to enter into an agreement with the United States Department of Housing and Urban Development ("HUD") in order to accept a grant in the amount of \$148,788.00 under HUD's Continuum of Care program (the "Grant"), to be used to pay for a leasing project that will provide seven (7) units of housing for homeless persons with chemical dependency or co-occurring (mental health/chemical dependency) disorders (the "Leasing Project"), for the period from December 1, 2017 through November 30, 2018 (the "Grant Agreement").

Authority is also requested for the County to enter into a sub-grant agreement with The Guidance Center of Westchester, Inc. ("The Guidance Center"), pursuant to which the County will sub-grant to The Guidance Center an amount not-to-exceed \$145,659.00 from the Grant and

The Guidance Center will use the funds to provide services for the operation and management of the Leasing Project, for the period from December 1, 2017 through November 30, 2018 (the "Sub-grant Agreement"). The Sub-grant Agreement will provide that The Guidance Center will contribute a cash match amount of \$8,708.00.

The \$3,129.00 in funds that HUD will provide to the County under the Grant Agreement that will not be provided to The Guidance Center under the Sub-Grant Agreement will be retained by the County to pay for the administration of the Grant.

The proposed Grant Agreement will serve a public purpose by providing the funds necessary for the Leasing Project. The proposed Sub-grant Agreement will serve a public purpose by providing the County with services for the Leasing Project.

The goal and objective of the proposed Grant Agreement is to provide the funds necessary for the Leasing Project. The goal and objective of the proposed Sub-grant Agreement is to provide the County with services for the Leasing Project.

The goal and objective of the proposed Grant Agreement is in the best interests of the County in terms of fiscal responsibility and public health and safety, as the proposed Grant Agreement will make available to the County federal funds for the Leasing Project that will provide seven (7) units of housing, which will help ensure the health and safety of the persons housed in those units. The goal and objective of the proposed Sub-grant Agreement is in the best interests of the County in terms of public health and safety, as the County having the services it needs for the Leasing Project will ultimately help ensure the health of such persons.

The goals and objectives of the proposed Grant Agreement and Sub-grant Agreement will be tracked and monitored by the Department of Community Mental Health.

Neither the proposed Grant Agreement nor the proposed Sub-grant Agreement constitutes a procurement. Accordingly, the provisions of the Westchester County Procurement Policy do not apply.

## RESOLUTION

Upon a communication from the Acting Commissioner of Community Mental Health, be it hereby

**RESOLVED**, that the County of Westchester (the "County") is hereby authorized to enter into an agreement with the United States Department of Housing and Urban Development ("HUD") in order to accept a grant in the amount of \$148,788.00 under HUD's Continuum of Care program (the "Grant"), to be used to pay for a leasing project that will provide seven (7) units of housing for homeless persons with chemical dependency or co-occurring (mental health/chemical dependency) disorders (the "Leasing Project"), for the period from December 1, 2017 through November 30, 2018; and be it further

**RESOLVED**, that the County is hereby authorized to enter into a sub-grant agreement with The Guidance Center of Westchester, Inc. ("The Guidance Center"), pursuant to which the County will sub-grant to The Guidance Center an amount not-to-exceed \$145,659.00 from the Grant and The Guidance will use the funds to provide services for the operation and management of the Leasing Project, for the period from December 1, 2017 through November 30, 2018, with The Guidance Center contributing a cash match amount of \$8,708.00 (the "Sub-grant Agreement"); and be it further

**RESOLVED**, that the Sub-grant Agreement is subject to County appropriations; and be it further

**RESOLVED**, that this Sub-grant Agreement is also subject to further financial analysis of the impact of any New York State Budget (the "State Budget") proposed and adopted during the term of this Sub-grant Agreement. The County shall retain the right, upon the occurrence of any release by the Governor of a proposed State Budget and/or the adoption of a State Budget or any amendments thereto, and for a reasonable period of time after such release(s) or adoption(s), to conduct an analysis of the impacts of any such State Budget on County finances. After such analysis, the County shall retain the right to either terminate this Sub-grant Agreement or to renegotiate the amounts and rates approved herein. If the County subsequently offers to pay a reduced amount to the Contractor, then the Contractor shall have the right to terminate this Sub-grant Agreement upon reasonable prior written notice; and be it further

**RESOLVED**, that the County Executive or his duly authorized designee is hereby authorized to execute any documents and take any actions reasonably necessary and appropriate to effectuate the purposes of this Resolution.
