On July 26, 2017, two (2) bids were received and opened for Contract No. 16-527-Rev. for HVAC and Refrigeration Equipment Upgrades, Coachman Family Center, White Plains, New York.

Two (2) contractors submitted bids for this project. The project was advertised on the Empire State Purchasing Group website, in addition to the Journal News (Westchester-Putnam Edition), and was viewed by twenty six (26) entities on the Empire State Purchasing Group website. In addition, e-mails were sent to those twenty six (26) entities and to an additional one thousand one hundred nine (1,109) suppliers and contractors.

The bids were reviewed by the Department and it was determined that Mengler Mechanical, Inc. submitted the low bid in the amount of \$569,720.00 and has proposed the utilization of the following subcontractor: Fran Corp. d/b/a All Bright Electric (Electrical Work), 100 Snake Hill Road, West Nyack, New York 10994.

The low bidder has been investigated and it has been found that Mengler Mechanical, Inc.:

- Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

The objective of this contract is to upgrade HVAC and refrigeration equipment at the Coachman Family Center for continuous and uninterrupted operation.
