On July 21, 2016 Your Honorable Board authorized the County, acting by and through Westchester Community College (the "College"), to enter into an agreement with JMZ Architects and Planners, PC, 190 Glen Street, PO Box 725, Glens Falls, NY 12801 ("JMZ") for consulting services in connection with the Space Utilization Study, Westchester Community College, Valhalla, New York (the "Agreement"). The Agreement was subsequently executed.

Authority of your Honorable Board is now hereby requested to amend the Agreement in order to increase to total not to exceed amount by \$64,000.00, to extend the termination date of the agreement to December 31, 2018 and to provide for additional services to be provided by JMZ in order to broaden its analysis to include all assignable space on the main campus and a complete and thorough update to the 2012 Facilities Master Plan that will inform the institution's future capital project requests.

In accordance with the original Agreement, the consultant conducted a space audit and utilization study that has quantified the amount of instructional space the College will need going forward. This amendment will be to broaden the analysis to include all assignable space on the main campus and a complete and thorough update to the 2012 Facilities Master Plan that will inform the institution's future capital project requests.

The consulting discipline encompassed in this Amendment is an integral part of the project that involves the same degree of skill, experience and complexity as the expertise generally described in the original project. Accordingly, this type of consulting discipline was originally contemplated in the Professional Prequalification Board and Professional Selection Board process that was duly conducted in connection with the award of the original Agreement.

The fee for the above services is for an amount of \$64,000.00, pursuant to an approved budget, bringing the total Agreement plus Amendment to \$153,600.00. In addition, the completion date of the Agreement shall be extended until Dec 31, 2018.
