The work under this contract consists of providing all necessary labor, material and equipment required to install new lift stations, hydraulic power units and all associated hydraulic piping and oil in addition to environmental cleaning of all components; as well as power unit pedestal installation and structural patching of existing pits at floor level.

The objective of this contract is to refurbish the existing bus maintenance bay lifts.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that the Central Maintenance Facility can continue to safely maintain the County's bus fleet.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

The Bond Underwriter or Surety must appear on the U.S. Treasury's listing of approved sureties (Department Circular 570) and all Sureties must be licensed to transact business in New York as a surety company; and be it further
