RE: AUTHORITY TO ENTER INTO A LICENSE AGREEMENT WITH

TRAHANAS AMUSEMENTS, INC., 4 MANHATTAN AVENUE, RYE, NEW YORK 10580 FOR THE OPERATION OF A CONCESSION RIDE KNOWN AS THE "FLYING WITCH" AT PLAYLAND PARK FOR THE PERIOD MAY 5, 2018 THROUGH SEPTEMBER 30, 2019.

Authority is requested of this Board for the County of Westchester to enter into a license agreement with Trahanas Amusements, Inc. for the operation of a concession ride known as the "Flying Witch" at Playland Park, Rye, New York for the period of May 5, 2018 through September 30, 2019 to cover the 2018 and 2019 operating seasons, which run May through September of each year respectively.

As consideration for this license privilege, Trahanas Amusements, Inc. will pay the County of Westchester a license fee of 38% of gross receipts per operating season.

The goal and objective of this agreement is to increase County revenue while providing a safe attraction for Playland patrons. This agreement promotes fiscal responsibility as the county will benefit from the additional revenue.

The objective of this agreement will be monitored using inspection and ridership reports.

The Westchester County Procurement Policy does not apply to concessions pursuant to Section 3(b) thereof, and, therefore, does not apply to this license agreement.

A Resolution is attached for your favorable consideration.

RESOLUTION

Upon a communication from the Commissioner of the Department of Parks, Recreation and Conservation, be it hereby

RESOLVED, that the County of Westchester is authorized to enter into a license agreement with Trahanas Amusements, Inc., 4 Manhattan Avenue, Rye, New York 10580 for the operation of a concession ride known as the "Flying Witch" at Playland Park, Rye, New York 10580 for the period May 5, 2018 through September 30, 2019 to cover the 2018 and 2019 operating seasons, which run May through September of each year respectively; and be it further

RESOLVED, that for this license privilege, Trahanas Amusements, Inc., will pay the County of Westchester a license fee of 38% of gross receipts per operating season; and be it further

RESOLVED, that the County Executive or his authorized designee is hereby empowered to execute any and all instruments and take such other actions as may reasonably be necessary to effectuate the purposes thereof.
