On February 7, 2018, no bids were received for Contract No. 11-557 for Phase I – Sewer System Rehabilitation, Saw Mill Sanitary Sewer District, Westchester County, New York.

Subsequently, discussions with contractors in attendance at the mandatory pre-bid meeting determined that modifications to the bid documents would facilitate bidding, and it is in the County's best interest to modify the specifications and re-bid.

Therefore, authority is requested to re-advertise as Contract No. 11-557-Rev.

The objective of this contract is to repair identified sources of infiltration, inflow, structural deficiencies, and other physical defects in pipeline and manholes. Pipeline defects may include broken and cracked pipe, separated joints, corrosion, and heavy root intrusion. Manhole defects may include offset frames, broken covers, root intrusion, infiltration, and inflow due to low-lying manholes.

This contract is in the public's best interest because it effectuates long-term repairs of these critical sewer system components avoiding potential adverse environmental impact to the surrounding properties and water bodies. This work is necessary to provide improved sanitary facilities that are in compliance with all applicable regulations, thereby promoting public health policies and laws.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

This resolution has been reviewed by the Law Department.

RESOLUTION

Upon communication from the Commissioner of Public Works and Transportation,

WHEREAS, on February 7, 2018, no bids were received for Contract No. 11-557 for Phase I – Sewer System Rehabilitation, Saw Mill Sanitary Sewer District, Westchester County, New York; and

WHEREAS, discussions with contractors in attendance at the mandatory pre-bid meeting determined that modifications to the bid documents would facilitate bidding, and it is in the County’s best interest to modify the specifications and re-bid; and

WHEREAS, authority to re-advertise as Contract No. 11-557-Rev. is now requested; now, therefore, be it

RESOLVED, that it is in the best interest of the County that Contract No. 11-557 for Phase I – Sewer System Rehabilitation, Saw Mill Sanitary Sewer District, Westchester County, New York, be re-advertised as Contract No. 11-557-Rev. for Phase I – Sewer System Rehabilitation, Saw Mill Sanitary Sewer District, Westchester County, New York; and be it further

RESOLVED, that adequate and sufficient security for the faithful performance of this contract shall be deemed to be receipt of a performance and payment bond in an amount equal to 100% of the total contract amount, and in a form approved by the County Attorney. The Bond Underwriter or Surety must appear on the U.S. Treasury's listing of approved sureties (Department Circular 570) and all Sureties must be licensed to transact business in New York as a surety company; and be it further

RESOLVED, that this advertisement for bids will state that pursuant to Chapter 308 of the Laws of the County of Westchester, the policy of the County is to encourage the meaningful and significant participation on County contracts for business enterprises owned by persons of color and women - Minority Business Enterprise (MBE) and Women Business Enterprise (WBE); and be it further
