On April 11, 2018, four (4) bids were received and opened for Contract No. 16-500 for Grit Handling Improvements, Yonkers Joint Wastewater Treatment Plant, Yonkers, New York.

The bids were reviewed by the Department and it was determined that Mace Contracting Corporation submitted the low bid in the amount of \$5,427,000.00, and has proposed the utilization of the following subcontractor: Filingeri Electrical Contracting Corp. (Electrical Work), 3510 Lexington Avenue, Mohegan Lake, New York 10547.

The low bidder has been investigated and it has been found that Mace Contracting Corporation:

- Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

The objective of this contract is to upgrade the grit handling system at the Yonkers Joint Wastewater Treatment Plant. Grit removal reduces wear and abrasion on downstream pumps and other mechanical equipment. In addition, this project will provide increased operator flexibility and reliability to the grit removal process.

This contract is in the public's best interest because it protects plant equipment, provides improved plant operability and reliability, and ensures that the plant's operations are safe and environmentally compliant, thereby enhancing the health and general welfare of the residents of Westchester County.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 16-500 be awarded to Mace Contracting Corporation in the amount of \$5,427,000.00.
