By a Resolution approved on July 20, 2017, your Honorable Board authorized the County of Westchester, acting by and through Westchester Community College (the "College"), to enter into a contract with Summit Security Services, Inc. ("Summit") for uniformed security services for the College for the period July 24, 2017 through August 31, 2018, with the College having the sole option to extend the contract for four (4) additional one-year periods. The contract was subsequently executed. The attached Resolution would authorize the College to exercise the first of its one year extension options for the period of September 1, 2018 through August 31, 2019, in an amount not to exceed \$2,590,315.53 for this option period.

The goal and objective of this contract is to protect the safety of students and property by providing security services for the College. The performance of Summit will be continually monitored by College staff to ensure that contractual obligations are met by Summit.

RESOLVED, that the County Executive or his authorized designee is hereby authorized to execute the above agreements on behalf of the County of Westchester.
