On June 6, 2018, four (4) bids were received and opened for Contract No. 16-526 for Miscellaneous Roadway Improvements, Warburton Avenue (C.R. #75-I), Village of Hastings-on-Hudson, New York.

The bids were reviewed by the Department and it was determined that Montesano Brothers, Inc. submitted the low bid in the amount of \$2,655,754.00.

The low bidder has been investigated and it has been found that Montesano Brothers, Inc.:

The objective of this contract is to replace substandard areas of asphalt paving.
